

Is cannabis legal in Malawi?

Yes, but only for medicinal and industrial purposes. Recreational use remains illegal.

What is Cannabis Regulatory Authority?

Cannabis Regulatory Authority (CRA) is a state corporation established by an Act of Parliament No. 6 of 2020.

What does CRA Do?

CRA is responsible to regulate the cultivation, propagation, storage, exportation, importation and distribution and use of cannabis (including C. sativa, C. indica, and C. ruderalis) for medicinal, industrial, and scientific applications.

What is the difference between Medicinal Cannabis and Industrial Hemp?

Medicinal cannabis contains high levels of Tetrahydrocannabinol (THC), the main psychoactive compound found in cannabis responsible for the "high" or intoxicating effects. In Malawi medicinal cannabis was legalised for medical purposes only (for pain relief, nausea control, and other medical conditions).

Industrial hemp has some traits of THC (below 1%). Industrial hemp like other plants contains Cannabidiol (CBD) a non-psychoactive element and does not cause a 'high' effect hence it is safe for consumption and commercial use.

What Products are Made From Industrial Hemp?

Currently, Malawi market has the following locally processed CBD products;

- i. Culinary Hemp Seed Oil

- ii. CBD infused Honey,
- iii. Tea
- iv. Shelled Seeds
- v. Protein Powder
- vi. Smoking Flower
- vii. Hair and Body Oil

What Additional Products Are Made from Industrial Hemp?

Kodi CRA imagwira ntchito yanji?

Kodi pali kusiyana kotani pakati pa Chamba Chamankhwala ndi Hemp ya Mafakitale?

Chamba chamankhwala chili ndi THC (mphamu ya chamba) yambiri ndipo ku Malawi kuno chimagwiritsidwa ntchito pomangira mankhwala. THC ndi mphamu yomwe imapangitsa kusintha kwa bongo kapena kumva uchidakwa pamene munthu wadya chamba chokhala ndi THC chimene ku Malawi kuno ndi chamankhwala. Chamba chamankhwala chinalolezedwa pa zolina za mankhwala okha, monga kuchotsa ululu, kuchepetsa chizungulire, komanso kuchiza matenda ena.

Hemp ya mafakitale ili ndi THC pang'ono kwambiri (osapitirira 1%). Monga zomera zina, hemp ya mafakitale ili ndi Cannabidiol (CBD), yomwe ndi mphamu ya mbeu yi koma sichimayambitsa kusintha bongo, koteri ndi yotetezeza kudya, kuyika mu zakudya, kumwa ngati hemp tiyi, kusuta komanso kugwiritsidwa ntchito njira zosiyasiyana.
